To the Brethren of the Grand Lodge of New Mexico:

Owing to the New Mexico Department of Health's latest guidance mirroring the United States Centers for Disease Control's guidance, it seems prudent to provide a letter of clarification to the Freemasons of New Mexico.

As outlined by federal health officials, the more transmissible Delta COVID variant continues to spread through primarily unvaccinated populations and can be carried by unvaccinated individuals. The latest guidance from the state <u>recommends</u> that fully vaccinated New Mexicans wear a face covering in all indoor settings out of an abundance of caution. At this time, there will be no updates to Edict #4. That may change if the state issues new guidance or a new health order.

The state health order still requires masks for unvaccinated individuals, as does Edict #4. Let me remind you to wear a mask if you are unvaccinated.

If you are vaccinated, masks are now recommended indoors, including lodge rooms. Please remember the immunocompromised, our youth groups and those unable to receive the vaccine when deciding whether to follow this recommendation. Any Worshipful Master or Head of Body may elect to enforce a mask mandate within their lodge or organization for any reason.

We're all in this together. I look forward to seeing you all in lodge through the rest of the year. As we move towards fall and cooler weather, the guidance may continue to change. I know that Masons, acting on the level, practicing brotherly love, relief, and truth, will continue to adapt to that guidance and prosper. Thank you all for your continued patience and perseverance.

To all Constituent Lodges and Brethren of the Grand Lodge of Ancient, Free and Accepted Masons of New Mexico: this communication is to be given the widest possible distribution among the Brethren and be placed within your Lodge minutes. As provided in Chapter 11, Powers and Duties of Grand Lodge Officers, Code 20, "Grand Master", Section (g).

Considering an updated Public Health Order from the New Mexico Department of Health (NMDOH), I hereby rescind Edict #3, issued on May 17th, 2021 and issue the following Edict:

Edict No. 4

July 6, 2021

It is my order that all meetings and events that would be held under the auspices of the Grand Lodge of New Mexico, including any Appendant Bodies (hereinafter, "in-person meetings") must adhere to the Covid Safe Practices defined by the NMDOH and outlined in the most recent Public Health Order. These practices include masks and social distancing for unvaccinated individuals and reporting of cases to the State. It is the responsibility of the Worshipful Master or Appendant Body head to ensure the Public Health Order is correctly followed for all in-person meetings. Vaccination status relies on an honor system. Remember your obligation to not defraud your lodge.

Additional requirements for in-person meetings are outlined in this Edict and shall be followed. All dispensations normally required while conforming to this Edict are considered granted.

• The Worshipful Master of each Constituent Lodge shall decide whether to conduct in-person meetings or continue virtual meetings. Virtual

meetings are not approved for tyled business, but may be used for presentations, updates, and other untyled business. Virtual meetings may be opened before or after lodge, or during refreshment and must be disconnected or disabled during tyled business.

- The decision to conduct in-person meetings for each Appendant Body organization is at the discretion of the head of that organization but must balance parent organization guidance and building owner-tenant agreements.
- Report any positive cases to both the State of New Mexico and the Grand Secretary.
- Food or drink may be served in masonic facilities. If you are a state
 permitted food service facility, you must complete the New Mexico
 COVID-Safe Training Program for Restaurants and complete all items
 in the COVID-Safe Checklist for Food Service for every in-person
 meeting.

Issuance:

This Edict is to be read at the first regular communication after receipt, and Lodges should share it with their members.
