



## Monthly Dues Payment Plan

Montezuma Lodge No. 1 is offering all members the option of making their annual dues payments in twelve (12) monthly payments beginning around the 10<sup>th</sup> day of January. Annual dues are \$130.00 a year. This program will allow Montezuma Lodge to debit \$10.83 directly from your checking or savings account and \$10.87 in December to make your \$130.00 total. That comes out to about .36¢ cents a day.

You can join anytime. Just be aware that the first month(s) will be prorated to the current month's withdrawal.

For Example, using the chart above, if you decide to start this program in July, your first debit from your bank will be \$75.81, then \$10.83 for the remainder of the year for the exception of December which will be \$10.87.

Never worry about paying for the full dues again around the holiday season and always be current. Fill out the "Dues Monthly Payment Agreement" now.

# Dues Monthly Payment Agreement

I \_\_\_\_\_ hereby request that Montezuma Lodge No. 1 accept monthly payments towards yearly dues membership fees.

I understand monthly payments made must equal the full amount of the dues membership fees for the year established by Montezuma Lodge No. 1 and Grand Lodge per capita fees. Yearly dues are due January of each year.

I further understand and agree that monthly dues being collected are for the yearly dues of the next calendar year.

I further understand and agree that participating in the Dues Monthly Payment Agreement at any other month of the year other than January, I will be debited a prorated amount the first month followed by the monthly installments thereafter.

Either party may terminate this Agreement upon ten (10) days written notice. Upon termination, all funds held by Montezuma Lodge No. 1 shall be returned and it will be the members responsibility to pay his upcoming Dues on a timely manner.
